**AFTER THE PRESS CONFERENCE OF THE NATIONAL ELECTORAL COMMISSION
HELD ON
20 JUNE 2010 AT 23:59 CET AT THE NEC'S HEADQUARTERS**

On 20 June 2010 at 23.59 CET the next press conference was held concerning the Polish Presidential Elections 2010.

NEC's Chairman Judge Stefan Jaworski opened the conference of the National Electoral Commission by announcing the partial unofficial results of the Presidential Election as at 23:47 CET on 20 June 2010.

On the basis of the data received electronically about the results of the election in 4 069 polling stations, i.e. 15,79% of the total number of polling stations, the National Electoral Commission announces that the partial unofficial results of the election with regard to the number of votes cast for individual candidates are as follows:

- 1) Number of eligible voters: 4 262 728;**
- 2) Number of ballot cards issued: 2 283 507;**
- 3) Turnout: 53,57%;**
- 4) Total number of valid votes cast in the country: 2 266 313;**
- 5) Number of valid votes cast for individual candidates was:**

NEC's Chairman Judge Stefan Jaworski announced that the data had been submitted by polling stations located across the country, after being verified by Regional Electoral Commissions and confirmed as official results.

The National Electoral Commission has not recorded any election protests, however, Judge Stefan Jaworski observed that if any, the protests should be filed at the Supreme Court.

The next announcement of the National Electoral Commission, concerning 40% of the results will take place as the data from the commissions are submitted.
